POLICY ON FIELD TRIPS

All field trips are included in the price of the session. Transportation will be provided by Laidlaw Bus Service. All campers are expected to go. There will be no one left at Hamlin Park Day Camp. Permission slips will need to be filled out and returned before the trip. Most field trips are scheduled for Tuesdays and Thursdays. All field trips are subject to change.

SWIMMING

Swimming will be at the Community Pool. Children will swim at least twice a week. They will be tested on their swimming skills the first day. We will be walking to the Community Pool from Hamlin Park. Please bring swimsuit and towel each day.

OUR STAFF

Qualified recreation department staff certified in first aid and CPR will supervise your children at all times for the duration of camp. The ratio of staff to campers will be a maximum of 1:12.

POLICY ON HEALTH AND SAFETY

Physical Forms

Each child registered for day camp must have had a physical exam within the past 12 months. The child's immunization record **MUST** be submitted with the registration form.

Health Insurance

All participants in the program are required to have their own health and hospitalization insurance. This information is required on the registration form. The Town of Aurora will not pay for medical expenses for any injury or illness incurred by participants of this program.

Emergency Treatment

When a situation arises where medical care beyond first aid is required a staff member will call 911 and our Medical Director. Parents will be notified immediately. Parents are required to give consent for emergency medical care on the registration form.

Illness

Children exhibiting signs of illness (red or runny eyes, fever, vomiting, diarrhea, etc.) should be kept at home. If a child becomes ill while in our care, a parent or guardian will be notified and asked to pick the child up immediately.

Medication

If your child requires medication during Day Camp hours, the camp Medical Director must receive medications (prescription and nonprescription) and they will be kept in a secure cabinet in the infirmary. A doctor's signature is required for ALL medications.

Admission to Camp:

For the enjoyment of all, campers are expected to follow the rules, show up and be picked up on time, follow directions from the counselors and have a good attitude. Any special needs must be discussed with the Camp Director prior to camp to verify that we have the appropriate staff to meet your child's needs. Refunds will be given in the event that we cannot accommodate your child's special needs.

PROGRAM OPERATION

Enrollment Policy

Hamlin Park Day Camp is available to Town of Aurora residents as well as nonresidents, age five to twelve. (Must have turned five by January 1, 2017 and attended kindergarten).

Resident registration will begin April 3rd, at 8:30 a.m.

Nonresident registration begins April 17th, at 8:30 a.m.

Discipline

The counselors will use a three strike rule when the need for disciplining a camper arises for breaking the camp rules.

1. Warning of violation

2. Time-out

3. Camper is brought to the main building for discussion and appropriate disciplinary action from camp staff.

If a camper receives three strikes, Camp Director and parents are notified. If inappropriate behavior continues, a camper may be dismissed from camp.

Child Drop-off and Pick-up

Children should be dropped off in the parking spaces along South Grove Street near the corner of Prospect Street. Drop off is at 9:00 am. Please **DO NOT** bring child before 9:00 am.

Pick up is **PROMPTLY** at 3:45 pm, in the same designated area as drop off. If a camper is walking or riding their bike home or if someone other than a parent is picking up a child, we will need a permission slip.

Day Camp T-Shirts

Hamlin Park Day Camp will provide a t-shirt at no extra cost to the camper. They should be worn each day of camp. T-shirts are mandatory for Field Trips.

Electronic Devices

We will **NOT** be responsible for electronic devices at camp. Please do not allow your camper to bring cell phones, ipods, Gameboys etc.

Rainy Days

If we have a rainy day, **please dress appropriately**, the camp will be held at Hamlin Park. In inclement weather, camp will be held inside our camp recreation building.

Lunch & Snack

Lunch time is scheduled for 12:00 p.m. * Please bring a **BAG lunch** with a beverage, and a snack each day. Refrigerator will be available. **NO lunch boxes are allowed in refrigerator.** Snack time is around 10:00 a.m. each day.
